ELIGIBILITY FOR THE POST OF JUNIOR RESIDENTS

a) ELIGIBILITY:- MBBS degree from **Recognised** University/Institution and should be **Registered with Delhi Medical Council.**

b) PAY: - Rs.15600/- + Grade Pay Rs.5400/- plus usual allowances as admissible under the rules.

c) AGE LIMIT:- Below **40** Years as on **30th November 2013** for **General candidates**. Relaxable for SC/ST by 05 Years and for OBC by 03 years.

NOTE: If selected, Candidates should produce DMC Certificate before joining. Those candidates who have applied for registration to DMC shall not be allowed to join merely on production of DMC fee receipt.

d) Appointment will be initially for a period of six months extendable up to one year on the basis of satisfactory work & conduct report from the concerned HOD and written request from the Doctor concerned.

e) Candidate must not have completed one year Junior Residency from any Govt. Hospital.

i) Junior Residents who have completed one year of Junior Residency shall also be allowed to appear in the interview and will be offered residency only if fresh Junior Residents are not available.

ii) Post Graduate doctors who are interested to serve as Junior Residents will be allowed to join as Junior Residents if no fresh graduates are available.

iii) There would be no extension for any Junior Residents beyond one year of appointment under relaxed provision.

f) Internship : Must have completed one year internship on or after 16.12.2011. All successful candidates with longer period lapse after internship shall be listed in a separate list and this list shall be considered only after exhausting the first list.

Note:-

01 Appointment will be subject to medical fitness and verification of certificate of education qualification/age/caste/DMC/registration and internship completion certificate etc.

02 Candidates applying under OBC category shall be eligible only if their caste certificate is issued by the Notified/Competent Authority of Govt. of NCT of Delhi.

03 Vacancies may be filled in phases.

- 04 Panel of wait listed candidates will be prepared.
- 05 NO TA/DA will be paid for appearing in the interview.
- 06 For physically Handicapped candidates: Relaxation is admissible as per Govt. of India Rules.
- 07 The appointment and services will be governed under Residency Scheme.
- 08 In case SC/ST/OBC/ candidates are not available for the post of JR, the post shall be filled for 89 days on adhoc basis from general category candidates/Vice versa out of the candidates who shall appear for this interview on the basis of merit.
- 09 In case of interview could not be completed on the schedule date/duration of period, the interview shall be conducted on the following working days.
- 10 No correspondence or personal enquiries shall be entertained.
- 11 Bring all original documents along with their attested photocopies on the scheduled date of Interview.
- 12 FEES PAYABLE:- Rs.300/-(Non-Refundable) in the form of Demand Draft only issued by a nationalized bank in favour of MEDICAL SUPERINTENDENT, G.B.PANT HOSPITAL, payable at New Delhi.

JURISDICTION OF DISPUTE: - In case of any legal dispute the jurisdiction of court will be Delhi/New Delhi only.
