Terms and Condition for the Post of Junior Residents

Junior Resident

Applications are invited for the posts of Junior Residents (MBBS) purely on Adhoc & emergent basis in G.B.Pant Institute of Post Graduate Medical Education & Research, GNCTD for 89 days or till the regular incumbents join whichever is earlier and interview will be held on the first Tuesday of every month at 2 P.M and application in the standard format may be submitted up to the last day of the month in the Administration Branch.

Pay Band: - Rs 15600-39100/- with Grade Pay Rs. 5400/- plus usual allowances as per rules, HRA shall be granted as per rules.

Qualification: - The applicant must have passed MBBS (Foreign Degree will be accepted only after passing the Screening test conducted by NBE).

Eligibility: - MBBS with 01 year internship. Those applicants, who have completed two years of their internship before the last date of receiving of application, need not apply. Candidates who have completed their internship on or before last date for submission of application are eligible. He / She must have valid DMC registration at the time of joining. Those candidates who have applied for registration to DMC will not be allowed to join merely on production of DMC fee receipt. General instruction vide circular No. F. 121/26/2010/H&FW/DSHFW/1996-2045 dated 10.06.11 issued by the deputy secretary (H &FW), GNCTD.

1. **Age limit:** - Below 40 years on last day of submission of application and for reserved categories it will be as per government rule (OBC certificate must have been issued by the GNCTD), Relaxable for SC/ST by 05 Years and for OBC by 03 years.
2. Post Graduated Doctors who are interested to serve as Junior Resident will be allowed to join as Junior Residents if fresh graduate are not available.
3. Junior Residents who have completed one year of Junior Residency may be allowed to again appear for interview for selection and will be offered residency only if no fresh Junior Resident are available. There would be no extension for any Junior Resident beyond one year of appointment under relaxed provisions.

Further, it has been clarified that aforesaid provisions made in relaxation of the provision of the residency scheme are only the enabling provision. In the first place the recruitment has to be made strictly as per the residency scheme as circulated by the Ministry of Health & Family Welfare. In case of Non availability of the candidates as per the relevant scheme, recourse shall be taken to operate the list made in terms of the aforesaid relaxed provisions in any case no one shall be appointed from the second list for the second terms as has been stipulated above.

Complete application form along with the self attested copies of the following certificates should be submitted.

1. Date of Birth.
2. Must have valid DMC registration at the time of joining.
3. Internship completion certificate.
4. MBBS degree along with marks sheets and attempts certificate.
5. Experience Certificate, if any.
6. Undertaking by the candidate to the effect that information given is true to the best of his/her knowledge and nothing is concealed.

The selected candidates may have to make it convenient to join within three days of date of issue of offer letter/ Memorandum.

Note

1. **Appointment will be subject to medical fitness and verification of certificate of education qualification/age/caste/DMC registration**
2. **Candidates applying under OBC category shall be eligible only if their caste certificate is issued by the Notified Competent Authority of Govt. of NCT of Delhi.**
3. **The Vacancies are likely to vary and may be filled in phases.**
4. **Panel of wait listed candidates will be prepared.**
5. **NO TA/DA will be paid for appearing in the interview.**
6. **For physically Handicapped candidates: Relaxation is admissible as per Govt. of India Rules.**
7. **The appointment and services will be governed under Residency Scheme.**
8. **In case of interview cannot be completed on the schedule date/duration of Period, the interview shall be conducted on the following working days.**
9. **No correspondence or personal enquiries shall be entertained.**
10. **Bring all original documents along with their self attested photocopies on the scheduled date of Interview.**
11. **FEES PAYABLE:- Rs.300/-(Non-Refundable) in the form of Demand Draft only issued by a nationalized bank in favour of **MEDICAL SUPERINTENDENT, G.B.PANT HOSPITAL**, payable at New Delhi.**
12. **Posting of Junior Resident will be made in the interest of hospital.**

JURISDICTION OF DISPUTE: - In case of any legal dispute the jurisdiction of court will be Delhi/New Delhi only.
