- a) **MBBS with P.G Degree or Diploma in the concerned speciality from a Recognised University/Institution and should be Registered with Delhi Medical Council.**

**1. Eligibility of SR for Cardiology:-**

**MD/DNB in Medicine/Paediatrics/Pulmonary Medicine**

**Note: Candidate should produce DMC certificate with P.G. qualification at the time of submission of application/till interview.**

- b) **PAY :- Rs.18750/- + Grade Pay Rs.6600/- plus usual allowances as admissible under the rules.**

**c) AGE LIMIT: - Below 40 Years as on 31-08-14 for General candidates.**

Relaxable for SC/ST by 05 Years and for OBC by 03 years

**CONDITIONS OF RECRUITMENT:**

**1-The tenure of Senior Resident is for 03 years including any service rendered as Senior Resident earlier on adhoc/regular basis in any Institution. Appointment of Senior Resident on adhoc basis will be initially for a period of 89 days, which could be extended for a period of another 89 days up to 3 years or till the regular incumbent joins whichever is earlier, subject to the satisfactory work and conduct report from the concerned Head of the Department.**

**2-Other service conditions as prescribed from time to time by the Hospital will be applicable.**

**3-Inter Hospital/Inter Institutional transfer shall not be permitted**

**4-The candidates who are already in Govt. service should submit NOC.**

**5. Their service will be governed by residency scheme.**

6. Where no fresh candidates are available, candidates who have completed three years residency but are willing to serve as Senior Resident may also be allowed to appear in the interview.

i) Separate merit lists for fresh candidates and for others (those who have completed 03 years of residency) would be prepared.

ii) Firstly, the list containing names of fresh candidates would be exhausted for appointment as senior residents and the second list would be used only after that.

iii) Further all Senior Residents appointments from second list will be for one year only. It would not be renewable after one year.

Pay Band:-Rs.15600-39100/- with Grade pay Rs. 5400/- plus usual allowances as per rules. HRA Shall be granted as per rules.

Qualification:- The applicant must have passed MBBS (Foreign Degree will be accepted only after passing the screening test conducted by National Board of Examination).

Eligibility: Candidates who have completed their internship on or before last date for submission of application are eligible. He / she must have valid DMC registration at the time of submission of application/till interview.

General instruction vide circular No. F 121/26/2010/H&WF/DSHFW/1996-2045 Dt. 10.06.11 issued by the deputy secretary (H&WF), health & family welfare Department Govt of NCT of Delhi.

1. Age limit- below 40 years on dated 31.08.2014 and for reserved categories it will be as per Government rule (the OBC certificate must have been issued by the Govt of NCT of Delhi).
2. Post gradated doctors who are interested to serve as Junior Resident will be allowed to join as Junior Residents if fresh graduate are not available.
3. Junior Resident who have completed one year of Junior Residency may be allowed to again appear for interview for selection and will be offered residency only if no fresh Junior Resident are available. There would be no extension for any junior Resident beyond one year of appointment under relaxed provisions.

Fee Payable:- Rs.300/-(Non-Refundable) in the form of Cash/ Demand Draft only issued by a National Bank in l/o M.S.,G.B.pant Hospital, New Delhi., payable at New Delhi.

Further, it has been clarified that aforesaid provisions made in relaxation of the provision of the residency scheme are only the enabling provision. In the first place the recruitment has to be made strictly as per the residency scheme as circulated by the Ministry of Health & Family Welfare. In case of non availability of the candidates as per the relevant scheme, recourse shall be taken to operate the list made in terms of the aforesaid relaxed provisions in any case no one shall be appointed from the second list for the second terms as has been stipulated above.
